October 2021 HBR Update



Open Enrollment is Under Way!

Open Enrollment is here! Open Enrollment for the 2022 benefit year ends October 29, 2021.

Remind your employees who are tobacco users that they have until November 30, 2021, to visit their Primary Care Provider or a CVS MinuteClinic to complete a tobacco cessation counseling session in order to earn their premium credit for 2022. To ensure the credit is applied, please have them upload their office visit summary into the Document Center of eBenefits. This action is **ONLY** for tobacco users who want to reduce their monthly premium by \$60 per month in 2022. If an employee is NOT a tobacco user, they will simply need to attest to that during the online Open Enrollment process in eBenefits.

Please note that any new hires that were hired or enrolled after August 31, 2021, will not receive a 2022 Decision Guide in the mail. HBRs should refer those employees to the State Health Plan <u>website</u> to view their Decision Guide.

In addition, remember that employees must upload dependent verification documentation and provide a valid Social Security number (SSN) for dependents 6 months or older when adding a dependent to the Plan.

Reminder: NC FACETS Transition Training Next Month!

In preparation for the upcoming Blue Cross NC FACETS migration and eBilling changes, Blue Cross NC will host a detailed eBilling training with employing units in early November.

Beginning in mid-November, new logins will be required to access eBilling on the new platform. Your existing login ID will continue to be used to access bills on the old platform.

As a reminder, the State Health Plan (Plan) will be adjusting the schedule of the Social Security number (SSN) auditing in preparation for the FACETS migration. The normal process is for the Plan to make outreach to the HBRs on members with missing or invalid SSNs that are 6 months old or older as of the current month. In October, the Plan will looking at those members that are over 6 months old as of November 6. **Unique, valid SSNs must be provided for these members prior to October 14, 2021.**

Members over 6 months old that do not have a unique, valid SSN loaded in eBenefits timely will not be enrolled in 2022 benefits at Blue Cross NC. More importantly, it will cause the entire family to reject, which will delay the families' enrollment. A valid SSN is required to avoid rejection.

Please run/review the dependent census report (Data & Reporting, Standard Reports, Dependent Census) and address issues promptly. You will need to filter the "Dependent SSN" column to only invalid SSNs. Look for blanks/invalids and in the "Coverage" column look for yes.

Processing Rehired Retirees

In adherence to §135-48.40, a retiree employed full-time under an employing unit is no longer eligible for health coverage under the Retirement Systems and the employing unit is responsible for paying the employer premiums. Prior to the hire date, the HBR should notify the Plan of the need to terminate retiree health benefits by completing an <u>Exception Form</u>.

Upon approval of the exception to terminate the retiree health benefit, the HBR should establish the active benefit enrollment shell in eBenefits that will enable the retiree to enroll in coverage. As a reminder, the retiree will not be able to enroll until the retiree health benefit has been canceled.

Reminders:

- Permanent rehired retirees are eligible for the traditional plans (70/30 PPO Plan, 80/20 PPO Plan.)
- Employing units have the option to offer non-permanent full-time rehired retirees either the High Deductible Health Plan (HDHP) or the traditional plans.

Reminder: Coordinate with CVS on Flu Shot Clinic Plans!

HBRs planning worksite flu shot clinics are reminded to contact their assigned CVS pharmacist and talk through details well before the clinic occurs. CVS Pharmacy is a new vendor this year and the registration process and clinic requirements have changed. Details are available at the State Health Plan's HBR Worksite Flu Shot Program page. Flu shot clinics are still being planned and the program will run through December 31, 2021.


