What is the overall deductible?	\$1,250 person/\$3,750 family for in-network; \$2,500 person / \$7,500 family for out-of-network; doesn't apply to in-network preventive care.  Coinsurance and copayments do not apply to the deductible.	You must pay all the costs up to the <u>deductible</u> amount before this plan begins to pay for covered services you use. Check your policy or plan document to see when the <u>deductible</u> starts over (usually, but not always, January 1 <sup>st</sup> ).
