Open Enrollment Exception Period is Over!

- Tobacco credit exception requests are still rolling in. As a reminder, the Open Enrollment exception period, including requests for the tobacco credit, has ended. No further 2022 OE exceptions will be considered.
- The Plan verified 5,829 members completed a tobacco cessation visit or uploaded valid documents to eBenefits.
- Benefitfocus was provided a list of 2,463 employees to have their tobacco attestation credit removed effective January 1, 2022, which was completed in time for the February invoice.




Dual Premium Billing Ending

- Dual Premium Billing in two eBilling portals is ending. Retro activity balances in the Power MHS eBilling portal will be transferred to the FACETS eBilling portal.
- Debit balances will show on the "Fees and Other Services" tab of your current invoice and the description will be "MHS Adjustment." Credits will show as an "Adjustment" in the "Payment History" tab.
- The details of the MHS retro activity will be available in the Power MHS eBilling portal. Payments will no longer be accepted in the MHS eBilling portal and will only be accepted in the FACETS eBilling portal.
- Groups will be able to see credit adjustments starting 5/6/2022. Debits will appear
 with your next available invoice. Subsequent credits/debits will be handled
 monthly for the remainder of the year.

Qualifying Life Event Reminder

- Now Eligible for Other Coverage QLE will always require either a copy of the ID card that clearly shows the start date of the coverage or a letter, screenshot or other document that provides the start date information.
- Documents or ID cards without an effective date of coverage will delay the process of ending coverage for members and dependents.



Worksite Flu Clinics Not Offered This Year

- The State Health Plan will not be offering the worksite fluclinic program this year.
- Vendors continue to struggle with staffing issues, making it difficult to offer clinics at worksites throughout the state.
- If your group would like to arrange your own worksite flu shot clinic, please make sure to utilize an in-network provider to avoid your employees being charged.
- Receiving an annual flu vaccine continues to be one of the best ways to prevent the flu.
- The Plan encourages you to communicate to your employees that they should take advantage of other local opportunities such as pharmacies or provider offices to receive the flu vaccine.
